#### CHAIRWOMAN ROSENWORCEL ANNOUNCES THE NEW MEMBERS OF THE INTERGOVERNMENTAL ADVISORY COMMITTEE

Federal Communications Commission (FCC) Chairwoman Jessica Rosenworcel today announced the new members of the FCC's Intergovernmental Advisory Committee (IAC) and named Lieutenant Governor Garlin Gilchrist II of Michigan as Chair of the IAC, and Chairman and CEO Marshall Pierite of the Tunica-Biloxi Tribe of Louisiana as Vice-Chair. The IAC is comprised of elected officials of municipal, county, state, and Tribal governments that will meet with Commission officials to exchange views, information and advice on a range of telecommunications issues for which state, local and Tribal governments explicitly or inherently share responsibility or administration with the Commission.

#### **BACKGROUND AND MISSION**

On February 7, 2023, the Commission announced the reauthorization of the IAC,<sup>1</sup> and sought nominations for membership to the committee.<sup>2</sup> The reauthorized IAC will operate for two years, with an option for the Commission to reauthorize it at the end of the two-year period.<sup>3</sup> The term will commence with the new IAC's first meeting on April 18, 2024.

During its two-year term, the IAC may be tasked by the Chairwoman to produce specific deliverables that will further the Commission's programs, mission and objectives, which may include those related to increasing deployment and adoption of broadband services and any other tasks that may assist state, local, and Tribal government officials to better implement or describe the availability of Commission programs to their constituents and other members of the public. The Office of Intergovernmental Affairs (IGA) within the Consumer & Governmental Affairs Bureau is the Chairwoman's designee to serve as liaison to the IAC and provide oversight of the committee.

#### **COMPOSITION OF THE IAC**

Pursuant to Section 0.701(b) of the Commission's rules, the IAC should consist of thirty members (or their designated employees), with a minimum of four elected municipal officials (city mayors and city council members); two elected county officials (county commissioners or council members); one elected or appointed local government attorney; one elected state executive (governor or

#### INTERLOCAL GOVERNMENTAL COOPERATION CONTRACT FOR ADMINISTRATIVE SERVICES

#### STATE OF TEXAS COUNTY OF EL PASO

#### AGREEMENT:

This Agreement is made and entered into this <u>15th</u> day of <u>March</u>, 2024 by and between the <u>City</u> <u>of Dell City</u>, Texas, hereinafter referred to as "City", and the Rio Grande Council of Governments, hereinafter referred to as "RIOCOG", a political subdivision under Chapter 391 of the Texas Local Government Code, acting by and through its duly authorized executive officer.

WHEREAS, both "City" and "RIOCOG" are local governments as defined by Chapter 791 of the Texas Government Code, and this contract is made and executed under provisions of said chapter, which is commonly known as the Interlocal Cooperation Act; and,

WHEREAS, RIOCOG has professional administrative services expertise useful to the <u>City of Dell City</u> and desires to make such services available under the following terms and conditions;

NOW, in consideration of the mutual covenants and promises herein contained, the parties agree as follows:

RIOOCG agrees to provide certain administrative services, as described in Sections 1, 2, 3, 4, 5, 6, and 7 of this agreement, for the <u>City of Dell City</u>, pursuant to the receipt by the City of a <u>Texas Community Development Block Program</u> contract from the <u>Texas Department of Agriculture (TDA)</u>. In consideration for administrative services described herein, the City agrees to pay RIOCOG as described in Section 8 of this agreement.

#### **SCOPE OF WORK:**

#### SECTION 1. PROGRAM SET-UP

- 1.01 Provide general advice with respect to the implementation of the project and regulatory matters.
- 1.02 Furnish necessary forms and procedures for implementation of the project.
- 1.03 Provide technical assistance for the routine tasks to City personnel who will be directly involved in the program.
- 1.04 Assist the City in developing a record keeping system consistent with program guidelines, including the establishment and maintenance of program files.
- 1.05 Serve as liaison for the City during any monitoring visits by staff representatives of either the Texas Department of Agriculture (TDA) or the U. S. Department of Housing and Urban Development (HUD).
- 1.06 Assist the City in meeting all special condition requirements.
- 1.07 Prepare and submit to TDA all required periodic progress reports and compliance reports.

1.08 Assist the City in meeting citizen participation requirements, fair housing, civil rights and personnel requirements which may be qualifying factors for participation in the Community Development Block Grant Program (CDBG).

#### SECTION 2. FINANCIAL MANAGEMENT

- 2.01 Assist the City in documenting its ability to manage grant funds as required by the state.
- 2.02 Assist the City in establishing and maintaining separate bank accounts, journals, and ledgers as necessary for this project.
- 2.03 Assist the City in submitting the required depository and signature forms to TDA.
- 2.04 Assist the City in preparation and submission of requests for payment of funds by TDA.
- 2.05 Assist the City in establishing procedures to handle the use of any CDBG program income.

#### SECTION 3. ENVIRONMENTAL REVIEW

- 3.01 Prepare an environmental assessment of the project.
- 3.02 Coordinate environmental clearance procedures with state and local officials and other interested parties.
- 3.03 Document environmental comments.
- 3.04 Prepare any required environmental reassessment.
- 3.05 Prepare request for release of funds and certifications.

#### SECTION 4. AQCUISITION

- 4.01 Prepare required acquisition report(s), if any, on behalf of the City.
- 4.02 Assist the City in determining the necessary documentation of ownership of City-owned real estate, rights-of-way, easements, or other real property rights, if any, which may be required by the state.
- 4.03 Assist the City with acquisition of real property or the rights of use to real property.
- 4.04 Maintain separate files for each parcel of real property acquired.

#### SECTION 5. LABOR STANDARDS

- 5.01 Assist the City in determining how much, if any, of the TDA contract activities will be carried out, in whole or part, by force account labor.
- 5.02 Assist the City in determining the necessity for hiring any temporary employees to carry out CDBG contract activities.

- 5.03 Assist the City in maintaining adequate documentation of personnel, equipment, and materials used in the project and of related costs.
- 5.04 Assist the City in documenting compliance with federal and state requirements for equal employment opportunity.
- 5.05 Assist the City in documenting compliance with minimum wage and overtime requirements.
- 5.06 Act as local labor standards officer, when needed.
- 5.07 Request wage rates from state, when necessary.
- 5.08 Obtain state verifications of construction contractor eligibility.
- 5.09 Submit Notice of Start of Construction, Notice to Proceed, Final Wage Compliance Report and other applicable labor standards reports.
- 5.10 Attend pre-construction conference and prepare minutes (as needed).
- 5.11 Review weekly contractor payrolls and conduct compliance activities.
- 5.12 Conduct construction employee interviews.
- 5.13 Maintain monthly employee utilization reports as required.

#### SECTION 6. EQUAL OPPORTUNITY

- 6.01 Assist the City in developing, implementing and documenting fair housing activities.
- 6.02 Maintain documentation of project beneficiaries as required.
- 6.03 Prepare work write-ups and cost estimates, when appropriate.
- 6.04 Conduct inspections and process final contract documents as required.

#### SECTION 7. PROJECT AUDIT/CLOSE-OUT

- 7.01 Prepare Project Completion Report, Minority Business Enterprise Report, Monthly Employee Utilization Report, documentation of fair housing activities, and Certificate of Expenditures and other applicable closeout paperwork.
- 7.02 Assist the City in responding to any monitoring findings in connection with inspections and project reviews by the state.
- 7.03 Assist the City in resolving any third-party claims.
- 7.04 Provide the City's auditor with CDBG audit guidelines when needed.
- 7.05 RIOCOG shall not be financially responsible for any audit findings or for payment for an audit.

8.01 The <u>City of Dell City</u> agrees to pay RIOCOG \$20,000 under the following schedule:

- 8.02 The <u>City of Dell City</u> shall receive funds from the Texas Department of Agriculture pertaining to this project and shall be responsible for the deposit, disbursement, and management of such funds.
- 8.03 Funds awarded to RIOCOG by the <u>City of Dell City</u> under the terms of this agreement are authorized under the provisions of the State of Texas Professional Services Procurement Act, Texas Government Code, Chapter 2254, Subchapter A, "Professional Services".

#### **TERMS AND CONDITIONS:**

#### SECTION 9. ADDITIONAL RIOCOG OBLIGATIONS

- 9.01 During the performance of this agreement, RIOCOG agrees as follows:
  - A. RIOCOG will not discriminate against any employee or applicant for employment because of national origin, religion, race, creed, sex, familial status, or gender. RIOCOG will take affirmative action to ensure that applicants are employed and during the course of employment, are treated without regard to national origin, race, religion, creed, sex, familial status or gender. The actions will include, but are not necessarily limited to, employment up-grading, promotion, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.
  - B. When soliciting or advertising for employees, RIOCOG will clearly state that all qualified applicants will receive consideration for employment without regard to race, religion, creed, sex, or national origin.
  - C. RIOCOG will furnish all information and reports of Executive Order 11246 of September 24, 1965, and by the rules, regulations, and relevant orders of the Secretary of Labor, or pursuant thereto, and will permit access to its books, accounts, and records by the <u>City of Dell City</u> and the Secretary of Labor for

the purposes of investigation to ascertain with such rules, regulations and orders.

D. If the Secretary of Labor determines that RIOCOG does not comply with rules, regulations, or orders issued by the Secretary, this agreement may be cancelled, terminated or suspended, in whole or in part, and RIOCOG may be declared ineligible for further participation in government contracts under provisions of Executive Order #11246 of September 24, 1965, or by rules otherwise provided by law.

#### SECTION 10. CIVIL RIGHTS ACT OF 1964.

- 10.01 During the performance of this Agreement, RIOCOG agrees to the following:
  - A. Under Title VI of the Civil Rights Act of 1964, no person shall, on the grounds of national origin, race, religion, creed, sex, familial status, or gender, be excluded from participation in, be denied benefits of, or be subjected to, discrimination under any program or activity receiving federal financial assistance.

#### SECTION 11. SECTION 109 OF THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974

11.01 During the performance of this Agreement, RIOCOG agrees as follows:

- A. No person in the United States shall, on the grounds of race, color, national origin, or sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity funded in whole or in part with funds made available under: "Section 3" Compliance in the Provision of Training, Employment and Business Opportunity.
- B. The work to be performed under this Agreement is on a project assisted under a program providing direct federal financial assistance from the Department of Housing and Urban Development Act of 1968, as amended, [12 U.S.C., 1701u.] Section 3 requires that to the greatest extent feasible, opportunities for training and employment be given to lower income residents of the project area and contracts for work in connection with the project be awarded to business concerns which are located in, or owned in substantial part, by persons residing in the area of the project.
- C. The parties to this Agreement will comply with the provisions of said Section 3 and the regulations issued pursuant thereto by the Secretary of HUD set forth in 24 CFR 135, and all applicable rules and orders of HUD issued prior to execution of this contract. The parties to this Agreement certify and agree that they are under no contractual or other disability which prevents them from complying with these requirements.
- D. The Contractor will send to each labor organization or representative of workers with which the Contractor has a collective bargaining agreement or other contract of understanding, if any, a notice advising the labor organization or workers' representative of contractor's commitments under the Section 3 clause, and shall furnish the <u>City of Dell City</u> copies of the notice in places available to employees and applicants for employment or training.

- E. The Contractor will include this Section 3 clause in every subcontract for work in connection with the project and will, at the direction of the applicant for, or recipient of, federal financial assistance, take appropriate action pursuant to the subcontract upon finding that the subcontractor is in violation of regulations issued by the Secretary of HUD, 24 CFR, Part 135. The Contractor will not subcontract with any person or business when the contractor has notice or knowledge that the subcontractor has been found in violation of regulations under 24 CFR Part 135.
- F. Compliance with the provisions of Section 3 and the regulations set forth in 24 CFR Part 135, and applicable rules and orders of HUD issued prior to execution of the contract shall be on the condition of the federal financial assistance provided to the project and shall be binding on the applicant or recipient for such assistance, its successors and assignees. Failure to fulfill these requirements shall subject the applicant or recipient, its contractors and subcontractors, its successors or assignees, to those sanctions specified by the grant or loan agreement or contract through which federal assistance is provided, and to such sanctions as are specified by 24 CFR Part 135.

#### SECTION 12. PERIOD OF AGREEMENT, AGREEMENT TERMINATION, CONTRACT REPRESENTATIVE, AND PROCEDURE FOR AMENDING

- 12.01 Both parties agree that it is intended that all performances under this agreement are to be accomplished within two years of the date of its execution unless amended by mutual agreement of the parties. In any event, it is agreed and understood that RIOCOG shall be paid for performance rendered under this agreement.
- 12.02 This agreement may be terminated by either party upon thirty (30) days' notice in writing by one party to the other. Upon such termination, if any, RIOCOG shall be paid any outstanding sums due RIOCOG within thirty (30) days of termination.
- 12.03 It is further understood and agreed by the parties that RIOCOG is not responsible or liable to third parties for performance or non-performance by the <u>City of Dell City</u> under terms of this agreement as allowed by the laws and constitution of the State of Texas.
- 12.04 RIOCOG designates as its Contract Representative with the <u>City of Dell City</u>, its Executive Director. All communications relating to this Agreement should be addressed and directed to the Executive Director, or to a designee expressly named by the Executive Director.
- 12.05 It is understood and agreed by the parties, that each is contracting independently; and that nothing contained herein shall be construed as giving rise to or creating partnership, joint venture, or employer/employee relationship.
- 12.06 It is further understood and agreed, by all parties, that should either party breach the terms of this Agreement, the only remedy shall be termination of the Agreement in accordance with provisions of Section 12 of this Agreement.

12.07 Either party may, from time to time, request changes in the scope of the services to be performed. Such changes, including any increase or decrease in the amount of compensation to RIOCOG, shall be mutually agreed upon by both parties and shall be incorporated herein by a written amendment to this Contract.

#### SECTION 13. INTEREST OF THE PARTIES

- 13.01 No member of the governing body of the <u>City of Dell City</u> and no other officer, employee, agent, or public official, who exercises any function or responsibility in connection with the planning or completion of the water improvement project has or shall have any personal financial interest, direct or indirect, in this contract or the work performed thereunder.
- 13.02 RIOCOG covenants that neither it nor any of its officers, directors, employees or agents has any financial interest in the project. RIOCOG further covenants that neither it nor any of its officers, directors, employees or agents shall acquire any interest, either direct or indirect, in the study area or any parcel therein, or any other interest which would conflict in any manner or degree with the performance of its services hereunder. RIOCOG further covenants that no person having any conflicting interest shall be employed for performance of its services under terms of this Agreement.
- 13.03 No person who is an employee, agent, officer, or official of RIOCOG who exercises or have exercised any functions or responsibilities with respect to the activities assisted under this contract who are in a position to participate in a decision making process or gain inside information with regard to such activities, may obtain a financial interest or benefit from the activity, have an interest in or benefit from the activity or have any interest in any contract, subcontract or agreement with respect to the activities or the proceeds either for themselves or those with whom they have family or business ties during their tenure or for one year thereafter.
- 13.04 Local Program Liaison: The <u>City of Dell City</u> has designated the <u>City Mayor</u> to be the primary contact for RIOCOG in all matters concerning this grant and interlocal agreement.

#### SECTION 14. MISCELLANEOUS

14.01 RIOCOG shall give the United States Department of Housing and Urban Development (HUD), the Inspector General of the U.S., the Comptroller of the Currency, the Comptroller General of the United States, the Auditor of the State of Texas, the Office or Rural Community Affairs (TDA), or the General Accounting Office or any of their duly authorized representatives, access to and the right to examine all books, accounts, records, reports, files, other papers, things, or property belonging to or in use by RIOCOG pertaining to this contract and the resulting project. Such rights to access shall continue as long as the records are retained by RIOCOG. RIOCOG agrees to maintain such records in an accessible location and to provide reasonable access to such records consistent with the Texas Public Information Act.

- 14.02 The party's signatory on behalf of RIOCOG and on behalf of the <u>City of Dell</u> <u>City</u>, respectively, do individually hereby certify that each is authorized to execute this agreement on behalf of each respective organization.
- 14.03 This agreement constitutes the entire agreement between the parties relating to the rights granted and the responsibilities assumed.
- 14.04 Should any deviation occur from any of the requirements of this Agreement or the Texas Community Block Development Grant contract, known to RIOCOG, or which becomes known to RIOCOG, then RIOCOG shall immediately inform the <u>City of Dell City</u> in writing.
- 14.05 RIOCOG shall maintain fiscal records and supporting documentation for all expenditures of contract funds pursuant to OMB Circular A-87. RIOCOG shall retain these records and supporting documentation for the greater of three years from completion of this project.
- 14.6 RIOCOG and the <u>City of Dell City</u> will work along with TDA and other parties to the grant (Example: Engineer, contractor, material supplier, regulatory agency, etc). to ensure that compliance is achieved in all areas of this grant. Should issues of non-compliance arise, the <u>City of Dell City</u> and RIOCOG will work towards reasonable solutions.
- 14.7 Percentage Share of Negligence. To the fullest extent permitted by law, a party's total liability to the other party and anyone claiming by, through, or under the other party for any cost, loss, or damage caused in part by the negligence of the party and in part by the negligence of the other party or any other negligent entity or individual, shall not exceed the percentage share that the party's negligence bears to the total negligence of the <u>City of Dell City</u>, RIOCOG, and all other negligent entities and individuals.
- 14.8 Mutual Waiver. To the fullest extent permitted by law, the <u>City of Dell City</u> and RIOCOG waive against each other, and the other's employees, officers, directors, agents, insurers, partners, and consultants, any and all claims for or entitlement to special, incidental, indirect, or consequential damages arising out of, resulting from, or in any way related to the Project.

**SUBJECT:** UTEP Population Study, by Annette Gutierrez

# DISCUSS AND ACT UPON AS NEEDED

# **INFORMATION:**

Board of Directors' approval is requested to allow the Rio Grande Council of Governments to enter into a contract with the University of Texas at El Paso (UTEP) for \$36,725 and use up to \$26,725 from the fund balance of the Far West Texas Water Planning Group program to pay for the costs.

The purpose of the contract is to conduct a population study for the Far West Texas Water Planning Group. The planning group consists of Brewster, Culberson, El Paso, Hudspeth, Jeff Davis, Presidio, and Terrell. However, the population study would cover all the counties referenced with the exception of El Paso County. El Paso Water will pay for their own study. The reason for the study is due to the Texas Water Development's reported Population Estimates, which shows considerable slower growth in El Paso County and nearly no growth in the other counties. The planning group is seeking the assistance of UTEP conduct its own population study.

On September 21, 2023, the Far West Texas Water Planning Group voted to use up to \$27,000 to allow the RIOCOG to enter into an Interlocal Agreement.

#### **COUNTY OF EL PASO**

This Interlocal Agreement ("Agreement") is made and entered into by and between University of Texas at El Paso ("UTEP"), a component of the University of Texas System, and RIO GRANDE COUNCIL OF GOVERNMENTS ("RIOCOG), a political subdivision of the State of Texas, on <u>March 12, 2024</u> ("Effective Date")

#### AGREEMENT

#### **SECTION 1. SCOPE OF SERVICES**

UTEP agrees to perform services as further described in the Scope of Work attached hereto as Exhibit "A", which is incorporated into this Agreement.

#### **SECTION 2. TERM**

The Term of this Agreement shall begin on the Effective Date and will remain for a term ending December 31, 2024.

#### **SECTION 3. PAYMENT TO UTEP**

RIOCOG shall pay to UTEP an estimated amount of \$36,725 for the services performed during the term of this Agreement, based on the rates established in Exhibit "A". UTEP agrees that at no time shall it make a claim against RIOCOG for more than the amount provided under the terms of this Agreement. The payment to UTEP shall be paid from current revenues available to RIOCOG from the Far West Texas Water Planning Group. This compensation will include all reimbursable costs including, without limitation: travel, lodging, reprographics, reproduction, cost of contractors in order to conduct the services described in Exhibit "A".

UTEP shall submit to RIOCOG a monthly invoice reflecting the services performed the prior month, which will include the details of the work completed. All work will be preceded by approval by the RIOCOG Project Manager or designee. Invoices shall be submitted in writing via email to the following email address: <u>annetteg@riocog.org</u>. RIOCOG agrees to pay invoices for all services performed in accordance with Chapter 2251 of the Texas Government Code. Upon dispute and proper notice to UTEP, RIOCOG may withhold payment to UTEP for the amount in dispute only.

#### **SECTION 4. INDEPENDENT CONTRACTOR**

Nothing contained in this Agreement shall be construed as establishing a partnership or joint obligations among the parties. RIOCOG and UTEP each retain the right to conduct its business as it sees fit.

Both Parties acknowledge that neither is an agent, servant, employee of the other, nor are the Parties engaged in a joint enterprise, and each Party is responsible for its own acts and deeds and for those of its agents or employees during the performance of the Scope of Work.

#### **SECTION 5. INSURANCE**

RIOCOG will not provide UTEP with any insurance coverage - professional liability, medical, or otherwise. UTEP shall be responsible for carrying its own insurance coverage as it deems appropriate based on the services to be provided.

Each entity may insure its own property, and neither party shall be liable for loss or damage to the real or personal property or any other special, indirect and/or consequential damages of any kind of the other arising from this Agreement.

# **SECTION 6. LIABIILTY**

This Agreement is not intended to alter or reallocate any defense or immunity authorized or available to either party by law.

# SECTION 7. APPLICABLE LAWS

UTEP shall comply with all Federal, State, and local laws and ordinances applicable to the Scope of Work and all applicable rules and regulations promulgated by all local, state, and national boards, bureaus, and agencies.

# **SECTION 8. GOVERNMENTAL FUNCTION**

The parties agree that in all things relating to this Agreement, RIOCOG and UTEP are performing a governmental function, as defined by the Texas Tort Claims Act. The parties further expressly agree that every act or omission by either, which in any way pertains to or arises out of this Agreement, falls within the definition of governmental function.

# **SECTION 9. SOVEREIGN IMMUNITY**

RIOCOG and UTEP reserve, and do not waive, their respective rights of sovereign immunity and similar rights and do not waive their rights under the Texas Tort Claims Act. No provision of this Agreement that imposes an obligation or restriction on either party not permitted by applicable law shall be enforceable.

# **SECTION 10. TERMINATION**

Either party may terminate this Agreement for convenience by giving the other party thirty (30) days written notice. Should RIOCOG or UTEP have cause to terminate this Agreement, the Agreement may be terminated immediately upon notification to respective parties of the cause for termination. Should early termination occur for any reason, UTEP shall accurately reflect such early termination and partial service in a final invoice, which shall be sent no later than thirty (30) days after termination becomes effective. RIOCOG shall compensate UTEP in accordance with this Agreement for work performed. Nothing contained herein or elsewhere in this Agreement shall require RIOCOG to pay for any services that are not in compliance with the terms of this Agreement and its attachments.

# **SECTION 11. MISCELLANEOUS**

A. *Deliverable Items.* All presentations, drawings, models, designs, formulas, methods, documents, and tangible items prepared for and submitted to RIOCOG by UTEP in connection with the services rendered under this Agreement shall belong exclusively to RIOCOG and shall be deemed to be works made for hire (the "Deliverable Items"). To the extent that any of the Deliverable Items may not, by operation of law, be works made for hire, UTEP hereby assigns to RIOCOG a no-cost, perpetual right of ownership in the Deliverable Items, and RIOCOG shall have the right to obtain and hold in its own name any registration, and any other registrations and similar protection which may be available in the Deliverable Items. UTEP agrees to give RIOCOG or its designees all assistance reasonably required to perfect such rights.

B. *Financial Records*. UTEP agrees to retain all books, records, and other documents relative to the cost of the Agreement for three (3) years after final payment (the "Inspection Period"). RIOCOG, its authorized agents, and/or state auditors shall have full access to and the right to examine any such documents during the Inspection Period.

C. *Notices*. All notices, communications, invoices, and reports under this Agreement shall be either hand-delivered or mailed, postage pre-paid in the United States Postal Service, to the respective parties at the respective addresses shown below, unless and until either party is otherwise notified in writing:

D. *Captions*. The captions of this Agreement are for information purposes only and shall in no way affect the substantive terms or conditions of this Agreement.

E. *Conflicting Provisions*. Any provision contained in any attachments to this Agreement, which may be in conflict or inconsistent with any of the provisions in this Agreement shall be void to the extent of such conflict or inconsistency.

F. *Governing Law and Venue*. This Agreement shall be construed and enforced in accordance with the laws of the State of Texas. Venue shall lie with a court of competent jurisdiction located in El Paso County, Texas.

G. *Severability*. Should any section, paragraph, or other provision of this Agreement be found invalid, such invalidity shall not affect the remaining provisions of this Agreement.

H. *Successors and Assigns.* UTEP and RIOCOG each binds itself, its successors, executors, assigns, and administrators to the other Party to this Interlocal Agreement and to the successors, executors, assigns, and administrators of such other Party in respect to all covenants of this Interlocal Agreement.

I. *Amendments*. By mutual written consent of the Parties, the scope of work and payment provisions of this Interlocal Agreement may be amended prior to its expiration.

J. *Signatory Warranty*. Each signatory warrants that the signatory has necessary authority to execute this Interlocal Agreement on behalf of the entity represented.

K. *Entire Agreement*. This Agreement, including attachments, constitutes and expresses the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements, whether written or oral. This Agreement shall not be amended or modified, except by written amendment, executed by both parties.
